



**The Newtown Cultural Arts Commission's 9th Annual Newtown Arts Festival 2020 is scheduled for Saturday, September 26<sup>th</sup> and Sunday, September 27, 2020 from 11:00 AM to 5:00 PM.**

The Newtown Cultural Arts Commission is accepting applications from Artisans and Small businesses who would like to participate in this year's festival. Once again, we anticipate an amazing festival and expect to attract well over 5,000 patrons.

The Newtown Arts Festival features a broad range of arts related activities at the festival with over 200 artists participating in workshops, presentations, lectures, dance, music & theatrical performances. A wide variety of food and refreshments will also be available for purchase.

**The Newtown Arts Festival is held outdoors, rain or shine.**

Each space is 10 x 10 feet on the grass soccer field owned by Parks & Recreation. ***Please note: Driving is not allowed on the field.*** Vendors must supply their own tables, chairs & electricity (see booth fees/info below). Security will be onsite. Displays may be left overnight if secured under a tent. **The Newtown Cultural Arts Commission is not responsible for loss or damage.**

All artists' work offered for exhibit and sale must be designed and created by the applicant. We look for handmade, original, and unique work by artists. International Arts will be considered. This event is **JURIED** by members of the Newtown Cultural Arts Commission. Vendors are reviewed on a first come basis. We reserve the right to decline space to anyone exhibiting inappropriate items during the application process as well as at the event. If not selected for the event, the vendor application fee will be returned.

**Booth Fee - \$150** (10 x 10 space for two days)

Artist/business supplies staked tent or canopy – REQUIRED Electricity not available.

***If selected, the booth fee is non-refundable. If NOT selected your booth fee will be refunded.***
