



The Newtown Cultural Arts Commission's 13th Annual Newtown Arts Festival is scheduled for Saturday, September 27th and Sunday, September 28th, 2025 from 11:00 AM to 5:00 PM. This is a different weekend for us this year. These dates were chosen by the Committee due to conflicts within our own organization and with the many events happening around the area. We are hoping this doesn't cause a conflict for you, but we understand if it does. Please reach out to Jennifer Cebry, if you have any questions at newtownartsfestival@gmail.com.

We are now accepting applications from **artisans and vendors** who would like to participate in this year's festival. We accept on a rolling, first come first serve basis and each application is reviewed/juried by members of the Newtown Cultural Arts Commission. We reserve the right to decline space to anyone exhibiting inappropriate items during the application process as well as at the event. If not selected for the event, the vendor application fee will be returned. All artists' work offered for exhibit and/or sale must be designed and created by the applicant. We look for handmade, original, and unique work by artists. International Arts will be considered.

Last year we had an amazing weekend with almost 100 vendors, attracting well over 5,000 patrons over the two days and our Friday night concert.

The Newtown Arts Festival is held outdoors rain or shine. However, if storms are anticipated with heavy rain and winds, this may cause cancellation. If the Commission has to cancel due to storms, we will refund your vendor fee. Otherwise, all fees are non-refundable.

Each space is 10 x 10 feet on the grass soccer field owned by Parks & Recreation. Vendors must supply their own tent, tables, chairs & electricity (see below). Security will be onsite overnight. Displays may be left overnight secured under a tent. *The Newtown Cultural Arts Commission is not responsible for loss or damage*.

**<u>Booth Fee</u>** - **\$175** (10 x 10 space for two days)

Artist/business supplies staked tent or canopy, tables, chairs, & electricity - Electricity is not available

IF selected, the booth fee is non-refundable. IF NOT selected you will be contacted and your booth fee will be refunded.
