



**The Newtown Cultural Arts Commission's 14th Annual Newtown Arts Festival is scheduled for Saturday, September 19th and Sunday, September 20th, 2026 from 11:00 AM to 5:00 PM.**

We are now accepting applications from **artisans & vendors** who would like to participate in this year's festival. This is a juried event and we also accept on a rolling, first come first serve basis. We reserve the right to decline space to anyone exhibiting inappropriate items during the application process as well as at the event.

If not selected for the event, the vendor application fee will be returned. All artists' work offered for exhibit and/or sale must be designed and created by the applicant. We look for handmade, original, and unique work by artists. **A CT Sales Tax# must be provided in order to participate. Food, pet food, hemp and cosmetic/skincare vendors must also be licensed with the appropriate Town/State Agency.**

Last year we had an amazing weekend with 100 vendors, attracting well over 5,000 patrons over the two days!!

The Newtown Arts Festival is held outdoors rain or shine. However, if storms are anticipated with heavy rain and winds, this may cause cancellation. If the Commission has to cancel due to storms, we will refund your vendor fee. Otherwise, all fees are non-refundable.

Each space is 10 x 10 feet on the grass soccer field owned by Parks & Recreation. Vendors must supply their own tent, tables, chairs & electricity (see below). Security will be supplied onsite overnight. Displays may be left overnight secured under a tent. ***The Newtown Cultural Arts Commission is not responsible for loss or damage.***

**Booth Fee - \$200** (10 x 10 space for two days)

Artist/business supplies staked tent or canopy, tables, chairs, & electricity if needed - Electricity is not available on the field.

***IF selected, the booth fee is non-refundable. IF NOT selected you will be contacted and your booth fee will be refunded.***
